Applicability	This policy is applicable for only the Operations Function under the purview of the Manager, Embassy REIT, its Special Purpose Vehicles (“ SPVs ”) and its Holding Company(ies) (“ Holdco ”).
Purpose	Established to outline our measures to reduce water consumption associated with our operations.
Aspects	<p>Water conservation is an integral aspect to ensure resource efficiency in our operations. We recognise the need to reduce our water footprint. In line with our commitments, we propose to adopt measures based on the UNSDG Goal 6: Clean Water and Sanitation.</p> <p>At Embassy REIT, we strive to undertake water conservation through the following measures:</p> <p>Responsible water consumption:</p> <ul style="list-style-type: none"> ▪ Ensuring compliance with all applicable legal requirements with respect to wastewater discharge standards. ▪ Monitoring of water consumption across all assets to increase water use efficiency. ▪ Ensuring treatment of wastewater and utilisation of the treated water within the portfolio. ▪ Promoting utilisation of stormwater, use of rainwater harvesting systems and water conservation fixtures and fittings. ▪ Implementing signages on water conservation awareness, procedures, checks and building awareness among other stakeholders on water conservation measures. <p>Stakeholder Engagement:</p> <ul style="list-style-type: none"> ▪ Engaging all relevant stakeholders including the community, statutory & regulatory agencies, non-governmental bodies, technical and subject matter experts, business partners, contractors, clients, occupants and our own employees in our efforts to address water conservation. <p>Awareness: Investing in building the awareness of our employees, partners and other stakeholders on water conservation measures.</p>

<i>Implementation and monitoring</i>	The ESG Committee shall monitor the implementation of this policy supplement and establish suitable processes, procedures and infrastructure to support compliance to this policy. ESG aspects will be linked to the Key Responsibility Area of senior executives, which also include aspects on water conservation.
