	<ul> <li>sustainable and ethical sourcing:</li> <li>Partnering with suppliers who adhere to our following sustainability principles: <ul> <li>Zero Tolerance on child labour, forced labour, workplace discrimination or harassment, bribery, fraud or embezzlement and use of conflict minerals or resources.</li> <li>Pollution control of all kinds (Air, Water Noise, Radiation)</li> <li>Ensuring occupational health and safety at the workplace and adherence to relevant labour laws</li> <li>Promoting ethical land use and rural development, recycling and/ or replenishment of resources and adoption of newer techniques and technology, as applicable to the suppliers.</li> <li>Ensuring transparent disclosure of sustainability efforts undertaken</li> <li>Engaging and supporting our suppliers to improve their sustainability performance through monitoring and feedback.</li> </ul> </li> <li>Recognizing and collaborating with those suppliers who are actively engaged in sustainability initiatives.</li> </ul>
