We are committed to imbibe all the elements of a safe and healthy workplace and have developed a comprehensive approach towards Indoor Environment Quality Management.</p> <p>At Embassy REIT, we endeavour to maintain a high level of indoor environmental quality through the following measures:</p> <p>Standards:</p> <ul style="list-style-type: none"> ▪ Establishing standards for workplace environment, periodically reviewing and maintaining the indoor environment as per the OSHAS standards <p>Lighting:</p> <ul style="list-style-type: none"> ▪ Adopting lighting methods as per best practices or national regulations without causing any adverse strain on the eyes <p>Monitoring of Various Parameters:</p> <ul style="list-style-type: none"> ▪ Regular monitoring of parameters such as Odours, Volatile Organic Compounds (VOC), Particulate Matter, Carbon dioxide and Noise <p>Damp conditions:</p> <ul style="list-style-type: none"> ▪ Ensuring that HVAC and cooling equipment are properly designed and operated to eliminate chronic respiratory health issues. ▪ Properly controlling temperature and relative humidity for thermal comfort.
